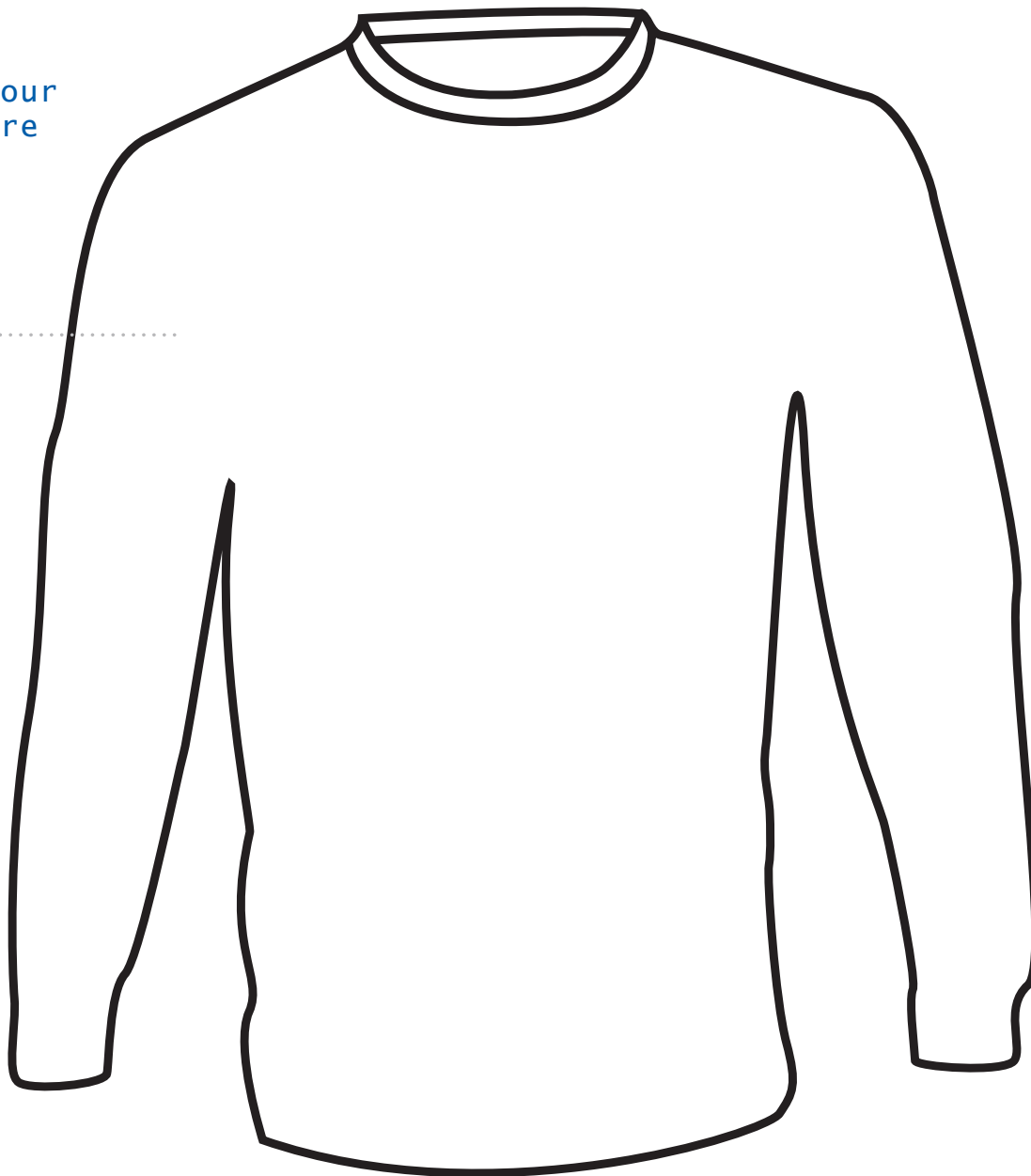

# DESIGN OUR NEXT JERSEY CONTEST RULES

## OFFICIAL CONTEST RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS CONTEST.

– (void where prohibited by law). A purchase will not improve chances of winning.

CONSUMER DISCLOSURE You have not yet won.

OPEN TO ANYONE WHO ARE AT LEAST 18 YEARS OLD AS OF THE DATE OF ENTRY (entrants under the age of 18 may enter the contest under their parent's name).

By entering this Promotion, entrants accept and agree to be bound by these Official Rules. Any violation of these rules may result in disqualification. All decisions of the judges regarding this Promotion are final and binding in all respects.

1. PROMOTION PERIOD. Promotion begins 12:01 AM ET Monday, September 1, 2008 and ends 11:59 PM ET. August 30, 2009, when all entries must be received ("Promotion Period").

2. ELIGIBILITY. This contest (the "Promotion") is only open to legal residents of the state of New Jersey who are at least 18 years old as of the date of entry, except officers, directors, members and employees of the Sponsor, the judging organization (if applicable), or any other party associated with the development or administration of this Promotion, and the immediate family (i.e., parents, children, siblings, spouse), and persons residing in the same household, as such individuals. You must include an original drawing or sketch of soccer jersey incorporating the likeness of the GK1 Logo with no words or phrases. Entrants must be the responsible designer ("Submission"). Entrants represent and warrant that their Submission is the original work of such entrant, or, if the design was done by someone else, that entrant has obtained permission from the designer to grant the rights granted herein, it has not been copied from others, and it does not violate the rights of any other person or entity. Limit: One entry per person and per e-mail address during the Promotion Period. All entrant information, including e-mail addresses, is subject to the respective Privacy Policy of the applicable Sponsor.

4. WINNER SELECTION AND NOTIFICATION. All entries will be judged on or about September 15, 2009 (the "Judging Date") by a panel of judges comprised of GK1 leadership. The judges will score entries based on the following criteria: originality (75%), and ability to re-produce in GK1's next product line (25%). The entry with highest overall score will be declared the potential winner (in the event of a tie, the entry with the higher score in the originality criteria will prevail). Any potential winner will be notified by mail, email and/or telephone on or before January 31, 2009. If a potential winner cannot be contacted, does not respond within two (2) days from the date the Sponsor first tries to notify him/her, and/or the prize or prize notification is returned as undeliverable, such potential winner forfeits all rights to win the Promotion or receive the prize, and an alternate potential winner may be selected. Upon contacting a potential winner and determining that he/she has met all eligibility requirements of the Promotion, including without limitation the execution of required waivers, publicity and liability releases and disclaimers, such individual will be declared the "winner" of the Promotion.

If allowed by the winner and appropriate parental documents authorizations are signed, it is intended that the winner's picture and bio will be included on the GK1 Web Site sometime in 2009 or 2010.

6. TAXES. All federal, state and/or local income and other taxes, if any, are the winner's sole responsibility.

7. OWNERSHIP AND LICENSE. All entry materials become the property of the Sponsor and will not be acknowledged or returned. The copyright in any Submission shall remain the property of the entrant, but entry into this Promotion constitutes entrant's irrevocable and perpetual permission and consent, without further compensation or attribution, to use such Submission for editorial, advertising and publicity purposes by the Sponsor and/or others authorized by the Sponsor, in any and all media now in existence or hereinafter created, throughout the world, for the duration of the copyright in the Submission.
